TANK LEASE AGREEMENT - Customer agrees to provide access to Blakeman Propane to install, service, and remove the propane tank. If gas line trenching is required, Customer agrees to call for locates and further agrees to hold Blakeman Propane harmless in the event that underground service lines (telephone, electrical, cable tv, etc.) are damaged as a result of trenching. Customer agrees to pay tank lease on an annual basis. Tank lease is non-refundable and non-transferable. Customer agrees that leased tank will not receive deliveries or repairs by anyone other than Blakeman Propane or its designee. If, at any time, 1) tank is not in active use, 2) service is stopped due to non-payment, 3) terms of this agreement are violated, Blakeman Propane retains the right to enter customer property and remove the lease tank after notifying the customer. The customer irrevocably grants Blakeman Propane onto customer's property to remove the leased tank. Notification to the customer shall be deemed given when sent by regular mail to the billing address stated on this application no less than 3 days prior to the date of removal. Customer's account will be credited for propane remaining in the tank. Credit will be assessed at the price charged on the last delivery. Customer system must comply with all applicable regulations, standards and codes and must pass a GAS CHECK inspection. Combustible materials shall not be stored within 10 feet of the tank. Structures and sources of ignition shall be distanced from the tank as required by the LP Gas Code.

INSURANCE REQUIREMENTS – Customer shall provide insurance coverage pursuant to the terms of Appendix 1 to this Tank Lease Agreement.

CREDIT TERMS: Charges are due upon receipt of propane. Charges not paid within 15 days of purchase of propane may be subject to a finance charge of 2% per month or 24% per annum. Failure to pay charges and/or interest may result in a referral collection. Customer agrees to pay all reasonable costs of collections, including attorney's fees and court costs. Budget payment plan may be available. Customers on budget payment plan are required to make monthly payments with an annual "true-up" to settle any remaining balance on their account. I understand that collection notices may be sent to me by email.
