Additional materials and labor will be subject to additional costs. If trenching is required, Blakeman Propane will call for utility locates. Customer agrees to pay for any charges that may occur for line locates or required permits and agrees to hold Blakeman Propane harmless in the event that underground service lines (telephone, electrical, cable tv, sewer, water, etc) are damaged as a result of trenching. Trenching may not be available in all locations. Propane is not included in fee.

LEASED TANK TERMS: **If tank is customer owned, tank lease terms are not applicable.**

1. **TANK** – This lease covers the tank/trailer and valves that are part of the tank only and is non-refundable and non-transferable.
2. **REPAIR** - The lines and regulators connecting the propane tank to the residence or other structure(s) supplied by the tank are the customer's property and responsibility. In the event that any lines or regulators require service, BPI may provide service and repair and reserves the right to charge the customer reasonable/customary rates for any service/parts provided.
3. **LIMITATIONS ON USE** - Customer will not permit any propane or other product to be delivered into the Leased Equipment by anyone other than BPI and must not be moved, handled, or maintained by anyone other than BPI or someone authorized by BPI.
4. **OUTAGE** - If requesting a delivery after normal business hours or the tank runs empty, an EMERGENCY DELIVERY FEE may be applied. If the tank is empty, a Leak Inspection will be performed.
5. **PROPERTY ACCESS** - BPI may enter customer's premises to install, perform necessary repairs or to remove the tank. BPI will remove the tank if the account is not kept current or as agreed upon.
6. **TERMINATION** - Upon termination of this lease and pick up of the tank, BPI may buy back any propane left in the tank with the exception of tanks installed on RV's. BPI will not buy back any propane left in a tank that was set on an RV. In the event customer sells the property, any remaining propane in the tank shall be part of the transaction between customer and the new owner. Customer may contact us at any time to obtain the value of the propane.
7. **CODE** - Customer system must comply with all applicable regulations, standards and codes and must pass a GAS CHECK inspection. Combustible materials shall not be stored within 10 feet of the tank. Structures and sources of ignition shall be distanced from the tank as required by the LP Gas Code.
8. **MISCELLANEOUS** – This tank lease is governed by the laws of Wyoming.

- **Routed** customers with accounts in good standing will have their tank filled monthly from November to March. Routed customers do not need to monitor their tanks to ensure they don't run out.
- **Call In** customers must monitor the level in their tank and "call in" when they want a delivery. Call In orders must be placed in advance so the delivery can be included in a regular route to avoid a service charge. We recommend you call in before your tank gets below 30%. Customers who run out of propane are required to have a Leak Check performed and may be subject to "off route" delivery fees. Minimum gallons for call in delivery = 200 Gallons.

CREDIT TERMS: Charges are due upon receipt of propane. Charges not paid within 30 days of invoice may be subject to a finance charge of 2% per month. Charge customers will be changed to a "cash before delivery" (CBD) and will call basis account when their balance becomes 60 days past due. Failure to pay charges and/or interest may result in a referral to collection. Customer agrees to pay all reasonable costs of collections, including attorney's fees and court costs. Budget payment plan may be available. Customers on budget payment plan are required to make monthly payments with an annual "true-up" to settle any remaining balance on their account. CBD "Cash Before Delivery" budget customers agree to pay for the summer fill in advance and then make the required monthly budget payments. Budget customers who become two months behind on payments will be taken off of the budget program and required to pay any balance immediately. I agree to receive collection notices by e-mail.
